CONFORMITY OF PRODUCTION

ATS Group, through its dedicated team, COP & surveillance carries out audits aimed at the initial and periodic evaluation of the production process and the approved product.

LABORATORIES

ATS Group, for carrying out the tests, subject to inspection activity, makes use of laboratories accredited in accordance with the ISO 17025 standard.

In the event that they are not, it is still able to carry out an audit activity to recognize the laboratory suitable for carrying out the tests.

APPROVALS

The main service of ATS Group involves testing and inspections, carried out thanks to the dense network of inspectors and affiliated laboratories, aimed at obtaining the approval certificate according to the ECE and EU Regulations.





INSPECTION BODY

ATS Group is an inspection body accredited by the Italian accreditation body «Accredia» in accordance with the ISO 17020:2012 standard.

As an inspection body, ATS Group only carries out conformity assessment activities and is therefore a third party body.

The inspection body must ensure that all inspections are carried out impartially, independently and competently.

At the conclusion of the inspection phase, the body issues a final inspection report in which the records of an activity are reported, indicating whether or not it conforms to a standard.









ADR COURSES
